2 of the five members of the Network who are part of the executive branch of  
3 government;

4 NOW, THEREFORE, IT IS ORDERED that the Chief Justice hereby appoints  
5 the following new members to the Network with the terms set forth below:

6 (1) Hon. Sarah Weaver is appointed to serve in a representative capacity for  
7 the New Mexico Judiciary for an initial term of two (2) years;

8 (2) Hon. Lea Kirksey is appointed to serve in a representative capacity for  
9 the New Mexico Judiciary for an initial term of three (3) years;

10 (3) Mary Galvez is appointed to the position previously held by Rosanna  
11 Soloperto, who resigned, to serve in the representative capacity of a professional  
12 guardian for an initial term of four (4) years;

13 IT IS FURTHER ORDERED that the following executive branch members  
14 shall be part of the Network serving the terms provided below:

15 (1) The Secretary of the New Mexico Aging and Long-Term Services  
16 Department or the Secretary's designee is appointed for a term of two (2) years;

17 (2) The Executive Director of the New Mexico Developmental Disabilities  
18 Planning Council is appointed for a term of three (3) years;

1           (3)    The Chief Executive Officer of the Interagency Behavioral Health  
2 Purchasing Collaborative is appointed for a term of four (4) years;

3           (4)    The New Mexico State Auditor is appointed for a term of two (2) years;

4           (5)    The Attorney General or the Attorney General’s designee is appointed  
5 for a term of three (3) years;

6           IT IS FURTHER ORDERED that all Network members are eligible for  
7 reappointment to new four (4)-year terms upon expiration of their initial terms;

8           IT IS FURTHER ORDERED that the Executive Committee of the Network  
9 shall be comprised of Hon. Daniel A. Bryant, Hon. Nancy J. Franchini, Tom  
10 Gardner, Peggy Graham, Mary Galvez, and Patricia Galindo until further order of  
11 the Chief Justice;

12           IT IS FURTHER ORDERED that Hon. Nancy J. Franchini shall serve as chair  
13 of the Network and its Executive Committee until further order of the Chief Justice;  
14 and

15           IT IS FURTHER ORDERED that the Administrative Office of the Courts  
16 shall provide staff support to the Network.
