OF JOSEPH M. MAESTAS TO THE WORKING  
INTERDISCIPLINARY NETWORK OF GUARDIANSHIP  
STAKEHOLDERS, AND THE CORRECTION OF THE  
TERM OF CHAIR HON. LEE KIRKSEY**

**ORDER**

WHEREAS, it appearing to the Court that multiple vacancies exist on the Working Interdisciplinary Network of Guardianship Stakeholders due to the expiration of the terms of Chief Justice C. Shannon Bacon, Anastasia Martin, Brian Colón, Margaret “Peggy” Graham, and DeAnza Valencia, and due to existing vacancies, and the Court being desirous of filling said vacancies, Chief Justice C. Shannon Bacon, Justice Michael E. Vigil, Justice David K. Thomson, Justice Julie J. Vargas, and Justice Briana H. Zamora concurring;

NOW, THEREFORE, IT IS ORDERED that, effective January 1, 2024, Chief Justice C. Shannon Bacon, Anastasia Martin, Margaret “Peggy” Graham, and DeAnza Valencia are reappointed to the Working Interdisciplinary Network of Guardianship Stakeholders for four-year terms, said terms to expire December 31, 2027;

1 IT IS FURTHER ORDERED that, effective January 1, 2024, Joseph M.  
2 Maestas is appointed to the Working Interdisciplinary Network of Guardianship  
3 Stakeholders for a four-year term, said term to expire December 31, 2027;

4 IT IS FURTHER ORDERED that, effective January 1, 2024, Chair Hon. Lee  
5 Kirksey is reappointed to the Working Interdisciplinary Network of Guardianship  
6 Stakeholders for a four-year term, said term to expire December 31, 2027;

7 IT IS FURTHER ORDERED that Hon. Lee Kirksey shall be eligible to serve  
8 a full four-year term upon the expiration of her current term;


9 IT IS FURTHER ORDERED that Hon. Lee Kirksey shall continue to serve  
10 as Chair of the Working Interdisciplinary Network of Guardianship Stakeholders  
11 until further order of this Court; and

12 IT IS FURTHER ORDERED that the remaining vacancies on the Working  
13 Interdisciplinary Network of Guardianship Stakeholders shall continue to exist until  
14 further order of the Court.
