MINUTES QUARTERLY MEETING of NM WINGS Held Via Zoom April 12, 2022

Welcome and roll call

The meeting was called to order at 9:04am. Roll was called. The following members were present: Justice Bacon, Judge Franchini, Judge Bryant, Ms. Martin, Mr. Colon, Mr. Snow, Sen. Duhigg, Rep. Ferrary, Mr. Gardner, Ms. Soloperto, Ms. Chavez Neuman, Ms. Graham, Dr. Burns, Ms. Galindo, Ms. Valencia. Ms. Pittenger was not present at roll call but joined shortly afterward.

Approval of minutes and agenda

There was a motion to approve minutes of the February 8 meeting. There was a second by Ms. Graham. The motion carried and minutes were approved.

Ms. Graham moved to approve the Agenda for the April 12 meeting. The second was by Ms. Galindo. The motion carried and the agenda was approved.

2022 legislation recap (SB 35)

Judge Franchini provided a recap of SB 35. She stated that the new legislation has been signed into law. She thanked Rep. Ferrary for sponsoring the legislation and noted that training for the judiciary would probably begin in June.

Mr. Jim Jackson: What's Next in Guardianship Reform

Judge F. introduced a guest speaker, Mr. Jim Jackson. Mr. Jackson made remarks, beginning with a summary of previous efforts at guardianship reform in NM. He reviewed the legislative mandate for NM WINGS and discussed specific provisions of a proposed Uniform Act, including alternatives to guardianship and more use of limited guardianships. He recommended looking at mechanisms for oversight of all players in the system. After his remarks, Mr. Jackson answered members' questions about alternatives, such as supportive decision-making. Members asked question and made comments about a variety of related matters, including irrevocable powers of attorney, adoption of the uniform code, protective arrangements, licensing, standing to appeal, and the grievance process.
