14 **ORDER**

15 WHEREAS, it appearing to the Chief Justice that twelve vacancies exist on
16 the Working Interdisciplinary Network of Guardianship Stakeholders due to the
17 expiration of the terms of Hon. Brian Biedscheid, Hon. Sarah V. Weaver, Alice Liu
18 McCoy, Tim Gardner, Veronica Chavez Neuman, Dr. Christine Burns, Steven
19 Simmerson, and Sen. Linda M. Lopez, and due to existing vacancies, and the Chief
20 Justice being desirous of filling said vacancies;

21 NOW, THEREFORE, IT IS ORDERED that Hon. Sarah V. Weaver, Alice
22 Liu McCoy, Tim Gardner, Veronica Chavez Neuman, and Sen. Linda M. Lopez are

1 reappointed to the Working Interdisciplinary Network of Guardianship Stakeholders
2 for four-year terms, said terms to expire December 31, 2028;

3 IT IS FURTHER ORDERED that Dr. Rex Swanda is appointed to the
4 Working Interdisciplinary Network of Guardianship Stakeholders for a four-year
5 term, said term to expire December 31, 2028; and

6 IT IS FURTHER ORDERED that vacancies for the Interagency Behavioral
7 Health Purchasing Collaborative co-CEO representative, two New Mexico
8 Legislature representatives, a family member not a guardian or conservator, a
9 judiciary member, and a protected person shall exist on the Working
10 Interdisciplinary Network of Guardianship Stakeholders until further order of the
11 Chief Justice.
