APPOINTMENT OF JOSEPH TURK,
SHANIA SPENCER, CLARISSA
ALVAREZ, AND LAURA E.
SANCHEZ TO THE WORKING
INTERDISCIPLINARY NETWORK
OF GUARDIANSHIP STAKEHOLDERS**

ORDER

WHEREAS, it appearing to the Chief Justice that multiple vacancies exist on the Working Interdisciplinary Network of Guardianship Stakeholders (WINGS) due to the resignation of the State Auditor’s Designee, Andrew Vallejos, and due to existing vacancies, and the Chief Justice being desirous of filling said vacancies;

NOW, THEREFORE, IT IS ORDERED that Joseph Turk is appointed to WINGS to fulfill the unexpired term of the New Mexico Developmental Disabilities Planning Council Executive Director’s designee, said term to expire December 31, 2028;

IT IS FURTHER ORDERED that Shania Spencer is appointed to the tribal-member vacancy on WINGS for a four-year term, said term to expire December 31, 2029;

IT IS FURTHER ORDERED that Clarissa Alvarez is appointed to the family guardian member vacancy on WINGS for a four-year term, said term to expire December 31, 2029;

1 IT IS FURTHER ORDERED that Laura E. Sanchez is appointed as the State
2 Auditor's designee on WINGS to fulfill the unexpired term of Andrew Vallejos, said
3 term to expire December 31, 2027;

4 IT IS FURTHER ORDERED that Joseph Turk, Shania Spencer, Clarissa
5 Alvarez, and Laura E. Sanchez shall all be eligible to serve two full four-year terms
6 upon the expiration of their current terms; and

7 IT IS FURTHER ORDERED that vacancies for two New Mexico Legislators,
8 one protected person, and one CEO of Interagency Behavioral Health Purchasing
9 Collaborative Representative shall exist on WINGS until further order of the Chief
10 Justice.

11 IT IS SO ORDERED.
